

STAGE 5

EMERGENCY - No Watering

- **ALL outdoor and non-essential uses of water are prohibited**

Mandatory Water Use Restrictions Cont.

All requirements of Stage 2, 3, and 4 shall remain in effect during Stage 5.

- Use of water to irrigate vegetation outdoors is prohibited
- A person may not use or allow the use of water to test or repair a permanently installed irrigation system or drip irrigation system.
- A person may not use or allow the use of water to wash or rinse an automobile, truck, trailer, boat, airplane, or other mobile equipment.
- A person may not use or allow the use of water to operate an ornamental fountain or structure making similar use of water, other than the aeration necessary to preserve habitat for aquatic life.
- A person may not use or allow the use of water to fill, clean, rinse, supplement, operate or maintain a tub, spa, fountain, pond, pool, or other container, feature, or improvement used, designed, maintained, or intended for aesthetic, athletic, or recreational purpose. This does not apply to the filling of non-aerating birdbaths or animal watering containers.
- A person may not operate a splash pad or other similar aesthetic or recreational use of water.
- A person may not use or allow water use to wash, rinse, or treat any outdoor surface including but not limited to a sidewalk, driveway, parking area, street, tennis court, patio, or other paved area or outdoor building surface.
- A person may not use or allow water use to operate a patio mister.
- A person may not use or allow the use of water in or related to a chemical lawn treatment unless specifically authorized in accordance with Section XI (C)(2) (*Variance*).

A person may not use or all the use of water for watering the ground around a building foundation to prevent or address foundation cracking except as specifically authorized in accordance with Section XI (C)(1) (*Variance*).

STAGE 1

MILD - Voluntary

- **Odd Addresses** - Monday, Wednesday & Friday
- **Even Addresses** - Tuesday, Thursday & Saturday

Voluntary Water Use Restrictions

A person should not irrigate outdoors at a residential facility or a commercial facility with an automatic irrigation system or a hose-end sprinkler system except on the following designated day:

Tuesdays, Thursdays, and Saturdays for customers with a street address ending in an even number (0, 2, 4, 6 or 8), and Mondays, Wednesdays, and Fridays for customers with a street address ending in an odd number (1, 3, 5, 7 or 9).

Water customers are requested to practice water conservation and to minimize or discontinue water use of non-essential purposes.

STAGE 2

MODERATE - Mandatory

- **Odd Addresses** - Monday, Wednesday & Friday
- **Even Addresses** - Tuesday, Thursday & Saturday
 - *Limited to the hours between 12:00 am (midnight) until 10:00 am of the morning of designated watering days and between 8:00 pm to 12:00 am (midnight) of the evening of designated watering dates*

Mandatory Water Use Restrictions

A person should not irrigate outdoors at a residential facility or a commercial facility with an automatic irrigation system or a hose-end sprinkler system except on the following designated day listed above.

**HOA may only run irrigation systems in common areas on Tuesdays, Thursdays, and Saturdays. No watering from 6:00 am to 10:00 am on Mondays, Fridays, and Sundays.*

STAGE 3

SEVERE - Mandatory

- **Odd Addresses** - Wednesday & Friday
- **Even Addresses** - Tuesday & Thursday
 - *Limited to the hours between 12:00am (midnight) until 10:00am of the morning of designated watering days and between 8:00pm to 12:00am (midnight) of the evening of designated watering dates*

Mandatory Water Use Restrictions

All requirements of Stage 2 shall remain in effect during Stage 3.

- Operation of a charity car wash is prohibited
- A person may not operate a splash pad
- A person may not operate a patio mister at a commercial facility except between the hours of 4:00pm and 8:00pm.
- A person may not use or allow the use of water to wash, rinse, or treat any outdoor surface. A person commits a separate offense for each outdoor surface washed
- Use of water to wash any motor vehicle, motorbike, boat, trailer, airplane, or other vehicle is prohibited. Such washing, when allowed, shall be done with a hand-held bucket or a hand-held hose. Vehicle washing may be done at any time on the immediate premises of a commercial car wash or commercial service station.
- Use of water to fill, refill, or add to any indoor or outdoor swimming pools, wading pools, or Jacuzzi-type pools if prohibited
- Operation of any ornamental fountain or pond for aesthetic or scenic purposes is prohibited except where necessary to support aquatic life or where such fountains or ponds are equipped with a recirculation system.
- Use of water for the irrigation of golf course greens, tees, and fairways is subject to the same limitations as residential customers.

**Use of water from hydrants shall be limited to designated fire hydrants for construction purposes but may be allowed under a special permit from Quadvest.*

**All restaurants are prohibited from serving water to patrons except upon request of the patron.*

**HOA may only run irrigation systems in common areas on Tuesdays, Thursdays, and Saturdays. No watering from 6:00 am to 10:00 am on Mondays, Fridays, and Sundays.*

Mandatory Water Use Restrictions Cont.

The following uses of water are defined as non-essential and are prohibited:

- Wash down any sidewalks, walkways, driveways, parking lots, tennis courts, or other hard-surfaced areas
- Use of water to wash down buildings or structures for purposes other than immediate fire protection
- Use of water for dust control
- Flushing gutters or permitting water to run or accumulate in any gutter or street
- Failure to repair a controllable leak(s) within a reasonable period after having been given notice directing the repair of such leak(s).

STAGE 4

CRITICAL - Mandatory

- **Odd Addresses** - Wednesday, Friday & Saturday
- **Even Addresses** - Tuesday, Thursday & Sunday
 - *Limited to the hours between 6:00am and 10:00am of the morning of designated watering days and between 8:00pm to 12:00am (midnight) of the evening of designated watering dates and shall be by means of hand-held hoses, hand-held buckets, or drip irrigation only*

Mandatory Water Use Restrictions

All requirements of Stage 2 & 3 shall remain in effect during Stage 4.

- Vehicle washing at commercial car washes and commercial service stations shall occur only between the hours of 6:00am and 10:00am and between 6:00pm and 10:00pm.
- The filling, refilling, or adding of water to swimming pools, wading pools, and Jacuzzi-type pools is prohibited.

**No application for new, additional, expanded, or increased-in-size water service connections, meters, service lines, pipeline extensions, mains, or water service facilities of any kind shall be approved, and time limits for approval of such applications are hereby suspended for such time as this drought response stage or a higher-numbered stage shall be in effect.*
